

TERMS AND CONDITIONS

Windhoek Draught NCP = 26 April – 30 June 2021

1. This competition is open to all Namibian citizens over the age of 18 years except employees and immediate relatives of employees of Namibia Breweries Limited ("NBL"), Ohlthaver & List Group (O&L), their advertising agencies and immediate families, as well as consultants, directors, associates and trading partners of such organizations and persons or anyone professionally connected with the competition.
2. The competition runs from 26 April – 30 June 2021. No entries will be accepted prior to 26 April or after 30 June 2021.
3. To enter the competition, consumers are encouraged to buy any Windhoek Draught pack (750ml RB, 500ml Can or 440ml NRB), SMS the underliner code of their bottle or can tab to 75050 to stand a chance to win.
4. SMS cost N\$1 each; free SMS's are not applicable.
